THIS CONTRACT IS AMENDED AS FOLLOWS:

ITEM ONE (1): SCOPE OF SERVICES, B. PRODUCT REQUIREMENTS - ITEM 3. Pricing is hereby updated to add the following to the end of the first paragraph of Network Service Company's Response:

All Janitorial and Sanitation Supplies, Equipment and Related Services are considered in scope of this contract. Products are considered core (as set forth on price list with an exception to gloves) or non-core (anything outside of core list and sold at market competitive pricing).

Due to extreme market fluctuations and manufacturer's price increases, effective June 8, 2020, Network Services Company will be implementing an emergency price increase on vinyl, latex, and nitrile gloves. Customer pricing for gloves will be based on contract price at the time the order is fulfilled and delivered. The actual pricing for gloves could be greater than when the order was placed.

ALL OTHER PROVISIONS OF THE CONTRACT SHALL REMAIN IN THEIR ENTIRETY.
