When it's done right, service continuity ensures that agencies can do their jobs effectively and meet the expectations of taxpayers because they always have access to data and applications.



PRIORITIZE YOUR IT SERVICE CONTINUITY FUNCTIONS TO AVOID OVERSPENDING

An in-depth Business Impact Analysis of core business processes allows agencies to prioritize which applications must be recovered and available immediately following an outage. Some applications can wait to be recovered, but it's not until an agency or organization conducts that review that it becomes clear what is most important and what is less urgent.

Effective service continuity means agencies never even notice when there's a disruption or downtime. That's because all data and applications have been replicated – not just backed up – and everything is stored safely at a reliable recovery site.
