To Whom It May Concern:

Since our last price adjustment, AIS continues to have cost increases. AIS regularly reviews our business costs seeking to remain competitive in the marketplace by offering customers the very best value. Due to continual cost increases that have become far too familiar across every business sector, we request to implement the following adjustments on March 1, 2024.

In addition to the price adjustment request, we request adding a new product category/line, Lounge Collection and updating our authorized dealer/reseller list. Enclosed you will find the proposed discount structure for this new product line as well as price list, brochure, and other marketing materials as well as our updated authorized dealer/reseller list.

List Price Increase Request

AIS requests a list price increase of 4% for all systems, casegoods, and tables -- except for Day-to-Day height adjustable tables and bases and E-Series height adjustable tables and bases. AIS also requests a 5% increase on LB Lounge. March PDF price lists will be available at the end of February and can be sent once they are completed. We have included supporting cost data in the form of supplier price increase notices for this price adjustment as well as attached U.S. Bureau of Labor Statistics (BLS) Producer Price Index (PPI) for our industry. No preliminary PPI data was used in calculations.

Across the office furniture industry, NAICS 337214, there has been an increase of 8.6% since our last price adjustment request to Region 14 ESC. Attached you will find the BLS PPI index for 337214. In addition to the increase across the industry, AIS has received several price increase notices from raw material suppliers. Since our last price increase request to Region 14 ESC, the cost of foam/insulation, laminate, shipping/freight, and fabric/textiles have all increased. Please see below for a summary of each supplier increase notice and the products it effects.

Foam/insulation used in our panel systems has risen 7% since our last price adjustment request to Region 14 ESC. This effects all panel systems (Matrix, Divi, and AO2) and some universal product lines such as tackboards. Foam/insulation is used in panel core assemblies for acoustical values.

The price increase from our laminate supplier is 25% for peel coat. Peel coat is a necessary protective layer for our laminate product lines including desking, casegoods, seating, and tables. Laminate is used on Calibrate Series, worksurfaces, LB Lounge, storage, and our entire tables product line.

Freight rates have increased for AIS as well as a fuel surcharge added to our transportation services. Attached is the notice received from one of our suppliers.



Our main fabric/textile supplier increased our overall pricing by 6%. Fabric is applied to our seating lines as upholstery, our pedestal cushions, panel systems, and tackboards just to name a few product categories/lines. Supplier price increase notice is included.

If at any point our suppliers reduce pricing and/or alleviate surcharges, we will revisit our list pricing to make appropriate reductions. We have controls in place that alert customer service representatives of pricing discrepancies. If items on an order are priced higher than in our system, we acknowledge at the reduced correct price. Region 14 ESC participating agencies will automatically be extended any price reductions.

Discount & Freight Structure Update Request

AIS is requesting to update the freight minimum which effects some of the discount tiers and eliminate steel storage discount tier that was created specifically for steel storage cabinets and steel bookcases. The steel items will be discounted per the Systems, Casegoods, & Tables discount table.

The new freight minimum will increase from \$17,500 to \$20,000. Orders under \$20,000 list will incur a 15% net freight charge. The new freight minimum effects the first tier in the Divi Fast Track discount table. The first tier will be \$20,000 - \$45,000 instead of the current \$17,500 - \$45,000,

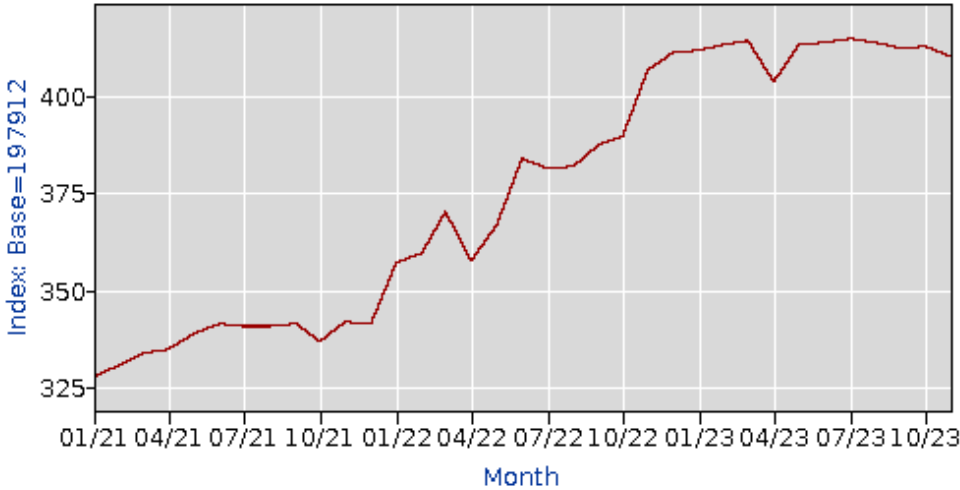

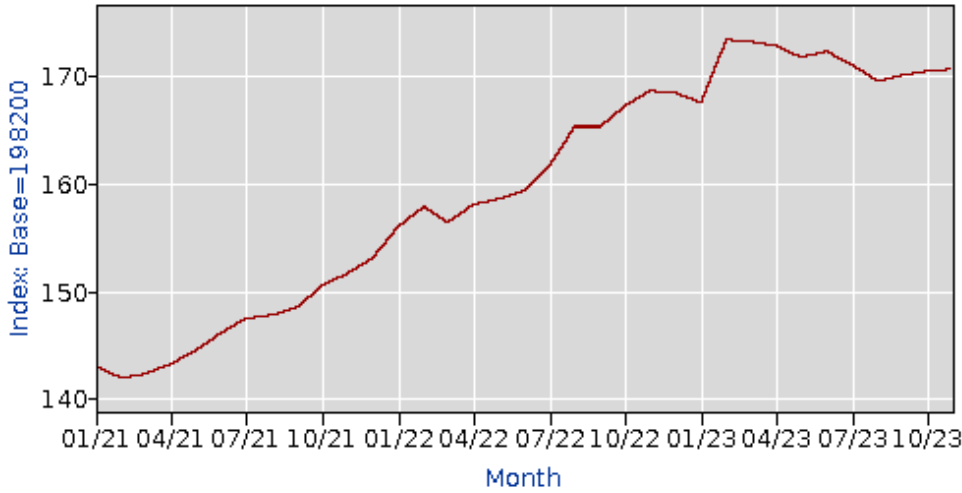

Hi Greg and Justin,

Thanks for your time today to discuss this challenge. Below is a recap of where things stand. As we discussed, we will work to do everything we can to uncover any possible solutions to this. I will also review your pricing as a whole to see if there is anywhere we can improve.

We were just informed by our carrier that that the Montgomery-Russel Bridge in Springfield, MA and along the main route into Rhode Island is now being repaired. The construction is currently planned for the next 2-3 years. Due to the construction, detours and designated DOT drop points, our carrier is now required to travel extra mileage to deliver material on our B-Train shipments. Effective immediately, they are increasing our freight rates, and we need to increase our pricing to Wurth and AIS. The additional freight and fuel surcharge combined is approximately \$895 (fuel surcharge can change from month to month). We have 6 loads due to ship this week and we will add the additional freight to the invoices to Wurth. I will also send a revised price page to Wurth with the below increases to the pricing to account for the added freight on future POs.

We will continue to work with our carrier and they will continue working with DOT to see if they can find a better solution in terms of routes and drop yards, etc. Should we come up with any other solutions, we will let you know right away.
