The University of California, Facilities, Maintenance and Capital Programs (FMC) Center of Excellence issued RFP 002364-Mar2021 – UC System-Wide Disaster Relief for FMC on March 19, 2021. Proposals were issued and received within the University of California's e-procurement platform, CalUsource. Because of this e-procurement platform, a solicitation at the University of California is made up of multiple documents in various formats and might appear as many combined documents instead of a single document. Proposal were opened on May 5, 2021 by 5:05 PST in the University of California's e-procurement platform, CalUsource, from the following suppliers:

The solicitation was evaluated based on the following evaluation criteria:

- Company Profile [9%]
- Corporate Responsibility Sustainability [16%]
- Capabilities [27%]
- Value-Add [17%]
- National Program [6%]
- Pricing [25%]

The Evaluation Committee reviewed, evaluated, and scored response based on the evaluation criteria. The scoring of the Evaluation Committee was then combined into a weighted average with the final proposal tabulation scoring resulting in:
