Top battles heading into signing day

Months before elite college basketball programs duel on the hardwood, they duke-it-out in high school gyms and in the living rooms of the top high school basketball players trying to lure them to their school.

From Duke's and Clemson's 11th-hour battle for Zion Williamson to North Carolina's fight with Oregon and others to land Cole Anthony, the recruiting trail has seen tumultuous battles over recent years.

Sharife Cooper, an Auburn commit who is ranked No. 2 in the Chosen 25, told USA TODAY Sports he "is coming hard" after Green.

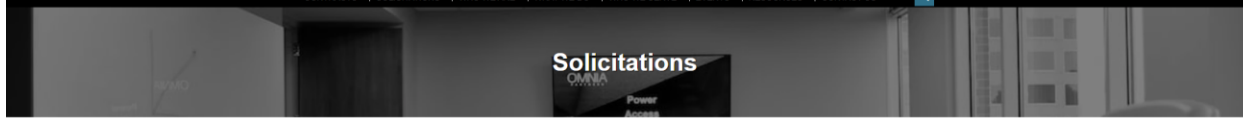
