





Southwest Airlines is back with its annual winter fare sale, dangling fares as low as \$49 one way to entice travelers to book trips outside the busy holiday travel rushes.

The nation's largest domestic carrier launched the three-day fare sale, one of two mega sales it has each year, on Tuesday. It runs through Thursday.

Travelers will find fares as low as \$49, \$79, \$99 and \$129 each way depending on the route (in some cases they may be lower!) for travel between between Nov. 13 and Feb. 12 with huge blackout dates around Thanksgiving and Christmas. Thanksgiving is Nov. 28 this year.

The promotion, which comes four months after its annual fall fare sale, is designed to fill seats during three slow travel periods: the pre-Thanksgiving lull, post-Thanksgiving travel slowdown before the Christmas and New Year's travel crush, and the post-holiday slowdown before Presidents Day and February school breaks.

The blackout dates for the sale are Nov. 22-Dec. 3 and Dec. 19-Jan. 5.

Don't worry about buyer's remorse. Southwest airline doesn't charge a change fee, so if you need to cancel a ticket after the sale, you'll get the amount of the airfare in the form of a credit good for a year.




