Reason for Price Update

Costs for Civix's EM Grants Manager product have been adjusted to reflect the increased cost of labor to recruit and retain highly qualified professionals for software development, operations, and support, increased overhead due to significant hosting and reporting improvements for the software, increased costs to meet federal and state security and accessibility requirements, and inflationary trends, as well as an increase in the number of programs included under the Hazard Mitigation Assistance program bundle, significant additional complexity and associated level of effort encountered on more recent State Financial System (SFS) integrations compared to earlier integration efforts, et al.
