Request for Proposal ("RFP")
by Region 4 Education Service Center ("ESC")
for Trenchless Technology Rehabilitation and Related Products and Services

 Question: What is the footage and diameter for the lateral CIPP, main line CIPP and main line pipe bursting?

Answer: There are not specific footages or diameters included. Offerors shall provide line-item fixed pricing, discount off, a combination with indefinite quantities, or other pricing as applicable to the products and services provided by Offer per Section IV. Evaluation Process and Criteria, 2. a) Products/Pricing i.

2. Question: RFP page 6, if we do not have proprietary information we are submitting, do we just submit 2-USB stick with proposal.

Answer: Yes.

3. Question: Appendix A, draft contract. Do we complete page one or just sign and complete the last page?

Answer: The Offer page will be signed but the 1st page of the draft contract does not need to be completed.

4. Question: On page 11, under a) Products/Pricing where it mentions "discount off", in the past we were not required to list a specific discount off, because you don't know how much of a discount you can offer until you know the scope of work from the potential user

Answer: A discount off structure is not required but an option if an Offeror wants to use that pricing mechanism. See Section IV. Evaluation Process and Criteria, 2. a) Products/Pricing i. for more details on other pricing mechanisms available, such as lineitem.

5. Question: Does this contract only pertain to school districts?

Answer: No. Resultant contracts from this solicitation are available to other public agencies nationally, including state and local governmental entities, public and private primary, secondary and higher education entities, non-profit entities, and agencies for the public benefit as described on page 2 of the RFP.

6. Question: Should we include all subcontractors that we work with in our proposal? If awarded, can additional subcontractors be added to any new work?

Answer: Yes, subcontractors should be included. If awarded, additional subcontractors can be added through a contract update form that would be provided. Contract updates do need to be approved by Region 4 Education Service Center.

7. Question: What are the approximate lengths, sizes of the pipes to be rehabilitated on the project?

Answer: See the Answer to Question #1 included in this Questions and Answers document.

8. Question: What type of rehabilitation will be used on the pipes? Is it going to be CIPP, Pipe Bursting, or Sliplining?

Answer: CIPP, Pipe Bursting, and/or Sliplining may be include. See the Scope of Work for more details as well as the Answer to Question #1 included in this Questions and Answers document.

9. Question: If it's CIPP, will it be heat-cured or light-cured?

Answer: There is no minimum volume guaranteed or specific projects outlined. Offerors may provide heat-cured and/or light-cured solutions. See the Scope of Work for more details as well as the Answer to Question #1 included in this Questions and Answers document.

10. Question: I would like to request a planholders or bidders list, and to confirm that the bid date and time are unchanged.

Answer: As of September 15, 2021 there have been no changes. A planholders or bidders list is not currently available at this time.
