The University of California, Facilities and Capital Programs Center of Excellence issued RFP # 002343 for Dorm Furniture and Related Service on March, 4<sup>th</sup>, 2021. Proposals were issued and received within the University of California's e-procurement platform, CalUsource. Because of this e-procurement platform, a solicitation at the University of California is made up of multiple documents in various formats and might appear as many combined documents instead of a single document. Proposal were opened on April 29th by 3:00 PM PST in the University of California's e-procurement platform, CalUsource, from the following suppliers:

- Appalachian
- DCI
- John Savoy & Sons
- RT London
- Sauder Manufacturing Co.
- Sustainable Furniture Inc. (SFI)
- The Brill Company

The solicitation was evaluated based on the following evaluation criteria:

- Program Pricing/Cost 30%
- Company Profile/General Capabilities 24%
- Services 24%
- Sustainability 15%
- Pricing Terms and Product 7%

The Evaluation Committee reviewed, evaluated, and scored response based on the evaluation criteria. The scoring of the Evaluation Committee was then combined into a weighted average with the final proposal tabulation scoring resulting in:
