This Amendment #4 to Agreement #2018.000208 (the “Agreement” as further defined below) is entered into by and between The Regents of the University of California (“UC”) and Fastenal Company (“Supplier”). UC and Supplier may be referred to as the “Parties” in this Amendment.

AMENDMENT TO AGREEMENT

The Agreement is now amended as follows:

- The contract term is extended from July 1, 2026, to August 31, 2027
- Supplier agrees to provide a new category of discounts to start on July 1, 2025.
