You have to hand it to the inaugural

Making its PGA Tour debut this week in the slot home to the Fourth of July, the tournament in the Land of 10,000 Lakes lured Captain America.

Patrick Reed, the red, white and blue wrecking ball during the 2016 Ryder Cup at nearby Hazeltine National Golf Club, is one of the headliners in a strong field that includes world No. 1 Brooks Koepka and Phil Mickelson.

It's Reed's first trip back to Minnesota since he produced numerous explosions of fireworks over three days as the U.S. won the Ryder Cup 17-11 three years ago. The memories from his 3-1-1 week flooded back as soon as he got off the plane, and he was so excited to be back in the state that he played the front nine of the tournament's host course, the TPC Twin Cities outside of Minneapolis, in the rain Monday.

"Coming back was awesome," Reed said. "Of course, I thought of the Ryder Cup. That was special week. Honestly, after Hazeltine, when I heard there was going to be an event up here, I was going to come to see the awesome fans again. I think it's great that the PGA Tour players can showcase their talents here.

"The tournament fits my schedule perfectly. It's two weeks before the (British) Open at Royal Portrush. And I always love experiencing new places with the game."

Joining him for Thursday's start are teammates from the Ryder Cup: Koepka, the four-time major champ who won the PGA Championship and finished second in the Masters and U.S. Open this year; Mickelson, the five-time ma-

jor champ and World Golf Hall of Fame member who captured his 44th PGA Tour title this year in the AT&T Pebble Beach Pro-Am; 2016 PGA champion and six-time Tour winner Jimmy Walker; and five-time Tour winner Ryan Moore.

Adding to the strong contingent are 12-time Tour winner and major champion Jason Day; five-time Tour winner Bryson DeChambeau; Kevin Na, a winner at Colonial this year; major champion Keegan Bradley; Nate Lashley, who won last weekend's Rocket Mortgage Classic in Detroit where he was the last alternate to get into the field; Tony Finau; and Hideki Matsuyama, who has made 24 consecutive cuts, the longest streak on Tour.

Also playing on sponsor exemptions are Minnesota natives Tom Lehman, who won five times on the PGA Tour, including the 1996 British Open, and 12 times on the Champions Tour; and Tim Herron, a four-time Tour winner.

If Reed produces like he did last weekend in the Motor City, he should be in contention. He finally broke out of a lengthy battle with his game by tying for fifth with rounds of 68-68-65-70. It was his first top-10 finish in 20 worldwide starts as he fell to No. 25 in the world, not the production he anticipated after winning the Masters and finishing fourth in the U.S. Open in 2018.

"My coach and my team kept saying, 'Hey, you're really close, you're really close,' but as a competitor, when you're not contending and playing late on Sundays, you're wondering what's going on," Reed said. "I see the swing, I see the putts I'm hitting, and yes, it looks really close, but how close am I?

"Last week was one of those weeks that I knew was there. I finally was able to see a score that I really felt represented how I was playing. I just needed a few things to click here and there, a couple more putts to fall, a few tee shots go my way. I got back into that mind-set where I was in attack mode trying to win."

The same mind-set he had in the 2016 Ryder Cup and the 2018 Masters.

"Last week was great and I'm ready and excited for this week," Reed said. "The field is very strong. The golf course is in great shape, and I'm looking forward to attacking it. Everything looks great right now. Can't wait until the Fourth of July."

Bodies of water at TPC Twin Cities, a 7,468-yard, par-71 that has been lengthened for this week's PGA Tour stop after hosting a PGA Tour Champions event since 2001. And in the Land of 10,000 Lakes, the course also restored many natural wetlands.

TPC Twin Cities was the site of the 3M Championship on the PGA Tour Champions since 2001 before receiving a PGA Tour event for 2019. The par-71, 7,468-yard course was originally designed by Arnold Palmer, and Minnesota native Tom Lehman was a consultant in the changes to the course that took

place to prepare it for a PGA Tour field. TPC Twin Cities often yielded low scores for Champions events, with the

former 54-hole 3M Championship tournament ranking in the top two for birdies on Tour in each of the last seven

Lehman, though, who will compete with a sponsor exemption, helped lengthen and narrow the course, The Star Tribune reported. Most of the holes have experienced only small changes, but the 18th saw its pond near the green double in size while its tee box was moved, too.
