The University of California San Diego issued RFP # 2018AO for Medical and Surgical Supplies on August 21, 2020. Proposals were issued and received within the University of California's e-sourcing platform, CalUsource. Because of this e-sourcing platform, a solicitation at the University of California is made up of multiple documents in various formats and might appear as many combined documents instead of a single RFP document. Proposal were opened on September 24, 2020 by 4:01PM PST in the University of California's e-procurement platform, CalUsource, from the following suppliers:

- Medline Industries, Inc
- Henry Schein Medical, A Division Of Henry Schein Inc
- Cardinal Health
- McKesson Medical Surgical Inc.
- ASP Global (administratively non-responsive)
- Caleb Milne (administratively non-responsive)
- Deepka Import LLC (administratively non-responsive)
- Sports Brand Group Inc (administratively non-responsive)
- Uweport LLC(administratively non-responsive)

The solicitation was evaluated based on the following evaluation criteria:

- Bidder Capability 15%
- Program Administration 10%
- Sustainability/Corporate & Social Responsibility 15%
- Price 60%

The Evaluation Committee reviewed, evaluated, and scored response based on the evaluation criteria. The scoring of the Evaluation Committee was then combined into a weighted average with the final proposal tabulation scoring resulting in:
