

Addendum No. 1 to Purchasing Agreement #2021002973

This Addendum #1 ("Addendum") to Purchasing Agreement #2021002973 (the "Agreement") is entered into by and between The Regents of the University of California, a California public corporation ("UC") on behalf of the University of California, San Diego and Henry Schein, Inc. ("Supplier") as of March 3, 2023 ("Effective Date").

AMENDMENT TO AGREEMENT

The Agreement is hereby amended as follows:

- 1. Capitalized terms used and not otherwise defined herein shall have the meanings ascribed to such terms in the Agreement.
- 2. The preamble of the Agreement shall be amended and restated in its entirety to read as follows:

"As a result of Request for Proposal # 2018AO UC San Diego Medical and Surgical Supplies, attached hereto as Attachment A (the "RFP"), this Master Agreement ("Master Agreement" or "Agreement") to furnish certain goods ("Goods") and services ("Services") described herein and in the documents referenced herein is made by and between The Regents of the University of California, a California public corporation ("UC") on behalf of the University of California, San Diego and Henry Schein, Inc. ("Supplier"). This Agreement is binding only if it is negotiated and executed by an authorized representative with the proper delegation of authority.

3. <u>Section 1 Statement of Work</u>: Section 1 is to be deleted in its entirety and replaced with the following:

"1. Statement of Work

Supplier agrees to provide (i) the Goods and Services referenced in the Scope of Work section of Attachment A, plus the addition of dental supplies offered through Supplier's dental catalog, (ii) the Catalog Discount Program attached hereto as Attachment B, (iii) the Market Basket referenced in Attachment C, which shall be provided by Supplier to UC in a separate electronic file, and any other documents referenced in the Incorporated Documents section herein (the "Incorporated Documents"), at the prices set forth therein and any other documents referenced in the Incorporated Documents section herein. Unless otherwise provided in this Agreement, UC will not be obligated to purchase a minimum amount of Goods and/or Services from the Supplier. "

- **4.** Attachment B Catalog Discount: Attachment B is hereby deleted in its entirety and replaced with Attachment B attached hereto.
- 5. The parties hereby agree that to the extent there is any inconsistency in any terms or conditions set forth in the Agreement and this Addendum, the terms and conditions of this Addendum shall control. Additionally, the parties hereby agree that all other terms and conditions of the Agreement shall remain in full force and effect, except as modified by this Addendum.
