If you used a credit, debit, or other payment card at certain Checkers or Rally's restaurants between December 2015 and October 2019, you may be eligible to receive benefits from a class action settlement.

A Settlement has been reached with Checkers Drive-In Restaurants, Inc. The Court will hold a hearing on December 8, 2020, at 10:00 a.m. to consider whether to approve the Settlement, and Class Counsel's request for attorneys' fees, costs and expenses, and service awards. You or your own lawyer may ask to appear and speak at the hearing at your own cost, but you do not have to.
