We are submitting an updated price list as part of our annual price update. As Lakeshore issues new catalogs, prices are updated each year, with new products offered.

As the direct manufacturer of Lakeshore products, we take into consideration a variety of factors on an annual basis to determine any increases/decreases in our catalog prices.

Because we develop, manufacture, deliver, and market our own products, our price increases are based on the increases in raw material cost, transportation, and other elements of the supply chain.

There is an average increase of less than 1%, over the total product assortment in the Lakeshore catalogs. The price increase does not reflect the full extent of increasing cost faced by Lakeshore Learning Materials.

Should there be any price decreases or other reductions to our prices, this savings will be reflected in updated pricing.

The price increases are reflected in the release of our new 2024 catalogs.
