The Cobb County, Georgia Department of Procurement issued RFP #20-6504 on January 24, 2020, to establish a national cooperative contract for Implements, Attachments, and Related Products for Tractors, Mowers, and Related Equipment.

The solicitation included cooperative purchasing language in the Overview (page 2) and Attachment A (page 30):

"Cobb County, GA, as the Principal Procurement Agency, defined in Attachment A, has partnered with OMNIA Partners, Public Sector ("OMNIA Partners") to make the resultant contract (also known as the "Master Agreement" in materials distributed by OMNIA Partners) from this solicitation available to other public agencies nationally, including state and local governmental entities, public and private primary, secondary and higher education entities, non-profit entities, and agencies for the public benefit ("Public Agencies"), through OMNIA Partners' cooperative purchasing program. Cobb County, GA is acting as the contracting agency for any other Public Agency that elects to utilize the resulting Master Agreement. Use of the Master Agreement by any Public Agency is preceded by their registration with OMNIA Partners (a "Participating Public Agency") and, by using the Master Agreement, any such Participating Public Agency agrees that it is registered with OMNIA Partners, whether pursuant to the terms of a Master Intergovernmental Purchasing Cooperative Agreement (MICPA), a form of which is attached hereto on Attachment A, or as otherwise agreed to. Attachment A contains additional information about OMNIA Partners and the cooperative purchasing program."

On March 12, 2020 proposals were received from the following offerors:

- Land Pride, A Division of Great Plains MFG., Inc.
- RhinoAg, Inc.
- Woods Equipment Co.

The proposals were evaluated by an evaluation committee. Using the evaluation criteria established in the RFP, the committee elected to enter into negotiations with Land Pride, A Division of Great Plains MFG., Inc. and proceeding with contract award upon successful completion of negotiations.

Cobb County, Georgia, OMNIA Partners, and Land Pride, A Division of Great Plains MFG., Inc. successfully negotiated a contract, and Cobb County, Georgia executed the agreement with a contract effective date of December 15, 2020.

Contract includes: All-season products associated with performing landscaping, field care, snow removal, de-icing, and other related services; products include but are not limited to: aerators, blades (such as 3 pt. blades and box blades), buckets, rotary cutters (such as pull type folding rotary cutters), drills (such as compact grain drills), flails, graders, grapples, hay tools, hitches, implements, loaders, mowers (such as 3 pt. finish mowers, 3 pt. and pull-type rotary mowers, and pull type mowers), disc harrows, rakes (such as landscape rakes), rotary tillers, seeders (such as no-till seeders), snow removal equipment, splitters, spreaders, tillers, and construction equipment attachments.

Term:

Initial twelve (12) months with automatic renewals for four (4) additional twelve (12) month periods and shall terminate on December 22, 2025.

Percent off list price (17-25% depending on equipment group).
