

## **RFP #20-SEH-20: Arts, Crafts, Framing, and Related Services Amendment #2**

This Amendment dated September 15, 2020 (hereinafter "Execution Date") is entered into between Michaels Stores, Inc., a corporation located at 8000 Bent Branch Dr., Irving, TX 75063 ("Contractor"). This document amends the Agreement made the 7<sup>th</sup> day of January, 2020.

Due to operational changes, the Darice wholesale operations is closing. The product assortment is replaced by MichaelsPro Pack via this Amendment.

The Parties hereby further agree as follows:

Remove all references to Darice Wholesale products and discounts (including "powered by Darice" language) and replace with MichaelsPro Pack products and discounts. References being removed and replaced include:

*1. From Best and Final Offer Proposal 2/19/2020*

- a. Remove the 2<sup>nd</sup> bullet (labeled MichaelsProEducation.com Purchases) and replace with the following:
  - MichaelsPro Pack Purchases: The discount offered on the MichaelsPro Pack assortment is 5% off. It's important to note that this pricing is comparable to on average 45% off the list price (also known as Manufacturer's Suggested Retail Price or MSRP) on most items.

*All other items under the Best and Final Offer Proposal 2/19/2020 shall remain.*

*2. From Price Proposal*

- a. Remove the 3<sup>rd</sup> bullet from the 1<sup>st</sup> section (labeled Wholesale Pricing) and replace with the following:
  - 5% off the MichaelsPro Pack assortment on MichaelsProEducation.com.
- b. Remove the 3<sup>rd</sup> bullet from the 2<sup>nd</sup> section (under Shipping and Ordering Minimums) and replace with the following:
  - MichaelsProEducation.com is not able to ship orders less than \$49

- c. Remove the 1<sup>st</sup> and 2<sup>nd</sup> bullets from the 3<sup>rd</sup> section (under Ordering Methods) and replace with the following:
  - Once a Participating Agency registers on MichaelsProEducation.com, approved users will be issued a membership card for use at Michaels stores and Michaels.com. They will be able to visit any local Michaels with the membership card and purchase products under the Master Agreement. They will also be able to use this card number on Michaels.com and order product for delivery to the requested ship to location or BOPIS (Buy Online Pickup in Store).
  - For orders on MichaelsProEducation.com customers will log in using their customer account number and can order via the website. Agency members can also call 1-866-432-7423 to place an order with our customer service department Monday thru Friday 8:30am to 5:00pm EST.

*All other items under the Price Proposal shall remain.*

Except as otherwise modified by this Amendment, the Agreement shall remain in full force and effect. This Amendment may be executed in counterparts, each of which is deemed an original, but all of which constitutes one and the same Agreement.
