The University of California, Facilities, Maintenance and Capital Programs (FMC) Center of Excellence issued RFP 00289-Apr2019 - UC System-Wide Elevator Maintenance for FMC on April 24, 2019. Proposals were issued and received within the University of California's e-procurement platform, CalUsource. Because of this e-procurement platform, a solicitation at the University of California is made up of multiple documents in various formats and might appear as many combined documents instead of a single document. Proposal were opened on June 3, 2019 by 3:00 PST in the University of California's e-procurement platform, CalUsource, from the following suppliers:

The solicitation was evaluated based on the following evaluation criteria:

- Company Profile [15%]
- Sustainability [14%]
- Module 1/2/3 [29%]
- Value-Add [12%]
- National Program [5%]
- Pricing [25%]

The Evaluation Committee reviewed, evaluated, and scored response based on the evaluation criteria. The scoring of the Evaluation Committee was then combined into a weighted average with the final proposal tabulation scoring resulting in:
