Region 4 Education Service Center's (Region 4 ESC) Department of Procurement issued RFP 22-09 on December 16, 2021, to establish a national cooperative contract for Exterior Surfacing Products, Services, and Paving Solutions.

The solicitation included cooperative purchasing language on page 2, Under Section I. Scope of Work:

Region 4 ESC, as the Principal Procurement Agency, defined in APPENDIX D, has partnered with OMNIA Partners, Public Sector ("OMNIA Partners") to make the resultant contract (also known as the "Master Agreement" in materials distributed by OMNIA Partners) from this solicitation available to other public agencies nationally, including state and local governmental entities, public and private primary, secondary and higher education entities, non-profit entities, and agencies for the public benefit ("Public Agencies"), through OMNIA Partners' cooperative purchasing program. Region 4 ESC is acting as the contracting agency for any other Public Agency that elects to utilize the resulting Master Agreement. Use of the Master Agreement by any Public Agency is preceded by their registration with OMNIA Partners (a "Participating Public Agency") and by using the Master Agreement, any such Participating Public Agency agrees that it is registered with OMNIA Partners, whether pursuant to the terms of a Master Intergovernmental Cooperative Purchasing Agreement, a form of which is attached hereto on APPENDIX D, or as otherwise agreed to. APPENDIX D contains additional information about OMNIA Partners and the cooperative purchasing program.

Socio-economic Outreach: To encourage participation of small businesses, minority owned businesses and women owned businesses, Texas Historically Underutilized Businesses were notified of the Request for Proposal.

On February 22, 2022 proposals were received from the following offerors:

The proposals were evaluated by an evaluation committee. Using the evaluation criteria established in the RFP, the committee elected to enter into negotiations with PaveConnect Logistics, LLC and proceeded with contract award upon successful completion of negotiations.

Geographic Preferences: No geographic preferences were included in the evaluation of the responses.

Region 4 ESC, OMNIA Partners and PaveConnect Logistics, LLC successfully negotiated a contract, and Region 4 ESC executed the agreement with a contract effective date of May 1, 2022.

Contract Includes (but is not limited to): Asphalt paving (from milling and resurfacing to simple overlays and complete parking lot construction as well as other custom projects), concrete (all phases of concrete repair including curbs, drives, sidewalks, valley gutters, dumpster pads, catch basin collars and aprons, concrete paving, decorative and stamped concrete), sealcoating, asphalt repair (a range of asphalt repair solutions, from patching individual potholes to replacing larger areas), crack sealing, pavement markings, speed bumps and signs, project management and asset management, and streetbond coatings.

Term:

Initial three-year agreement from May 1, 2022 through April 30, 2025 with the option to renew for two (2) additional one-year periods through April 30, 2027.

Pricing/Discount: Pricing available upon request. PaveConnect will utilize the RS Means Construction Procurement Catalog for all services offered under the Master Agreement.
