deals with Mercury's deals with Mercury's homosexuality. casual fans, his romance with Austin takes up a disproportionately large chunk of the movie. There's no indication he's gay until well into the film, when he checks out a guy going into his bathroom, and even after they break up, she remains an object of his affections. Personal manager Paul Prenter (Allen Leech) gets close to Mercury but is a Freddie's relationship with Jim Hutton (Aaron McCusker) is a stabilizing force a needed one after he's diagnosed with AIDS.
