This Amendment #3 to Agreement #2021002788 ("Agreement") is entered into between The Regents of the University of California (UC) and Supplier.

AMENDMENT TO AGREEMENT

The Agreement is hereby amended as follows:

Section 2.a is deleted in its entirety and replaced with the following:

The initial term of the Agreement will be from 1/26/21 and through 1/25/26 (Initial Term) and is subject to earlier termination as provided below. UC may renew the Agreement for 1 (one) 5 (five)-year period, by providing Supplier with at least 15 calendar days' written notice before the end of the Initial Term.

All other terms, conditions and provisions of the Agreement shall remain in full force and effect.

UC, by execution of this Amendment, hereby exercises its discretion to renew the Agreement for the five (5)-year renewal term referenced above. The renewed term shall commence on January 26, 2026, and shall continue through January 25, 2031, unless terminated earlier in accordance with the Agreement.
