The Board of Directors of Region 4 Education Service Center (ESC) issued RFP 20-06 on March 18, 2020, to establish a national cooperative contract for Athletic, Physical Education Supplies, and Team Uniforms.

The solicitation included cooperative purchasing language in Sections I. Scope of Work, National Contract (RFP, Page 2):

(RFP, Page 2) NATIONAL CONTRACT

The Region 4 Education Service Center ("ESC"), as the Principal Procurement Agency, defined in APPENDIX D, has partnered with OMNIA Partners, Public Sector ("OMNIA Partners") to make the resultant contract (also known as the "Master Agreement" in materials distributed by OMNIA Partners) from this solicitation available to other public agencies nationally, including state and local governmental entities, public and private primary, secondary and higher education entities, non-profit entities, and agencies for the public benefit ("Public Agencies"), through OMNIA Partners' cooperative purchasing program. The Region 4 ESC is acting as the contracting agency for any other Public Agency that elects to utilize the resulting Master Agreement. Use of the Master Agreement by any Public Agency is preceded by their registration with OMNIA Partners (a "Participating Public Agency") and by using the Master Agreement, any such Participating Public Agency agrees that it is registered with OMNIA Partners, whether pursuant to the terms of a Master Intergovernmental Purchasing Cooperative Agreement, a form of which is attached hereto on APPENDIX D, or as otherwise agreed to. APPENDIX D contains additional information about OMNIA Partners and the cooperative purchasing program.

Awarded Offeror's complete catalog and services that include but are not limited to: helmet accessory kits/mox box/chin straps, shoulder pads, shoulder pad accessories/parts, helmet facemasks accessories/parts, biolite, stock dummies/goal post pads, miscellaneous football/balls, bags/medical, rogers/world sporting goods, football field equipment, decals, Champro baseball/softball hard goods, baseballs/softballs, baseball/softball field equipment, basketball equipment, track equipment, stock football apparel, sublimated apparel, stock apparel, socks/belts, custom football apparel, custom baseball apparel, stock baseball/softball apparel, custom basketball apparel, basketball practice/stock apparel, volleyball HP and stock uniforms, hockey HP/non-cataloged uniform, lacrosse custom/stock uniforms, track HP uniforms, track stock uniforms, wrestling uniforms, and decorations.

Term:

Initial three-year agreement from October 1, 2020 through September 30, 2023 with the option to renew for two (2) additional one-year periods through September 30, 2025.
