To Whom it May Concern,

I am writing to inform you of an adjustment to the pricing of products provided by Sedia Systems, Inc., which went into effect January 2025. Our industry has experienced unprecedented inflation over the past few years, which has impacted the cost of goods and services globally. Despite this inflation, we have not increased our pricing in over 2 years. In the past year we have also had to make significant wage adjustments to help our workforce cope with the high rate of inflation and maintain a competitive position in the labor marketplace.

Here is a summary of how our cost of goods have increased from September of 2022 to January of 2025:

Steel	+ 6%
Foam	+ 4%
Fabric	+ 5%
Wood	+ 6%
Plastic	+19%
Electrical Components	+12%
Freight	+ 9%
Labor	+14%

To continue providing you with the highest quality products and maintain our service standards, we find it necessary to adjust our pricing structure accordingly.

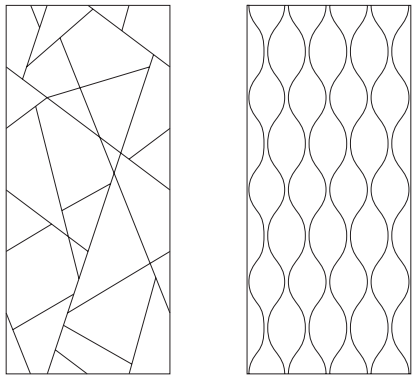
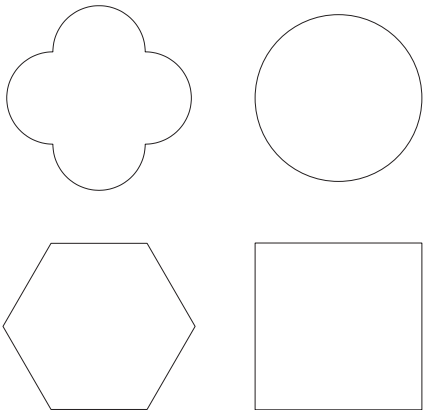
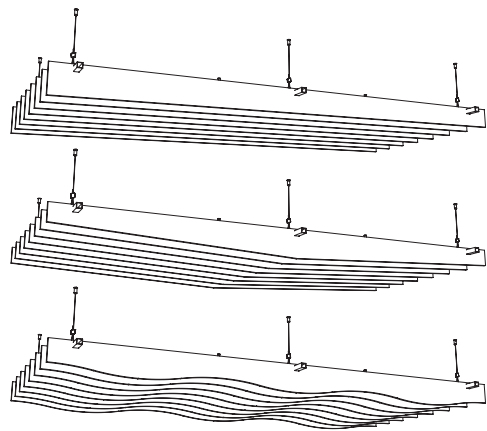
Effective January 2025, there was an across-the-board price increase of 5-6% on all our products. This adjustment is in line with the inflation surcharges that our vendors have implemented and is essential to sustain our business operations and service quality. TERMS & CONDITIONS GOVERN

The SEDIA SYSTEMS Terms & Conditions ("Terms & Conditions") shall apply to and govern all transactions, sales and purchases of seating and/or other products ("Products") and any related installation and/or other services ("Services") between SEDIA SYSTEMS and SEDIA SYSTEMS' end user, dealer, contractor or other customer ("Customer"). Except as otherwise expressly excluded by agreement, in writing, signed by SEDIA SYSTEMS and Customer, (i) these Terms & Conditions shall apply to and are incorporated into all agreements, whether written, oral or implied, with respect to the purchase of any Products and/or Services from SEDIA SYSTEMS by Customer pursuant to any quote, proposal, purchase order, invoice, contract, subcontract, or any other document related to the Products and/or Services provided by SEDIA SYSTEMS to Customer and into all orders, (ii) in the event Customer submitted an order, contract, subcontract or other Customer document reflecting terms and conditions applicable to Products and/or Services that conflict with these Terms & Conditions, these Terms & Conditions shall control, and (iii) Customer's acceptance of the Products and/or Services is conditioned upon acceptance by Customer of these Terms & Conditions and no others, and reflects Customer's assent to SEDIA SYSTEMS' Terms & Conditions as set forth herein. SEDIA SYSTEMS shall not be bound and no writing will constitute an "Order" unless and until such writing is acknowledged by SEDIA SYSTEMS as provided below. Customer shall be responsible for ensuring that the terms of the Order and any specification for the Services that are agreed in writing by SEDIA SYSTEMS and Customer, including any Customer approved drawings of the installation of the Products, are complete and accurate ("Specification"). Acceptance and acknowledgment of an Order by SEDIA SYSTEMS or if no written acceptance is issued, then the execution of an agreement between SEDIA SYSTEMS and its Customer or performance by SEDIA SYSTEMS of shipment of the Products or commencement of the Services constitutes a contract between SEDIA SYSTEMS and Customer ("Contract"), and the Contract is pursuant to these Terms & Conditions only, and constitutes a rejection of any additional or conflicting terms and conditions of Customer. To the extent drawings of the installation of the Products are approved by Customer after the Contract, Customer and SEDIA SYSTEMS agree that such approved drawings after the Contract shall be deemed part of the Specification and incorporated into the Contract. SEDIA SYSTEMS may modify these Terms & Conditions with notice. Changes shall be effective for all quotes issued by SEDIA SYSTEMS after the date of the modification.

PRODUCT PRICING

ALL FIXED SEATING PRODUCT PRICE LISTS ARE PRICED WITHOUT FREIGHT, SHIPPING AND INSTALLATION CHARGES. JUMPSEAT AND COMPLEMENTARY PRODUCT PRICE LISTS ARE PRICED WITH FREIGHT (ASSUMING SHIPMENT TO THE 48 U.S. CONTIGUOUS STATES) BUT WITHOUT INSTALLATION CHARGES. SEDIA SYSTEMS' prices applicable to all Customer orders shall be those in effect at the time SEDIA SYSTEMS receives a complete order from Customer unless: Customer and SEDIA SYSTEMS have in place a written special pricing or master supply agreement, which agreement specifies the prices to be paid by Customer; or Customer requests a Product shipping date to occur more than one hundred twenty (120) days after SEDIA SYSTEMS' receipt of Customer's order (in which case SEDIA SYSTEMS shall have the option to apply to Customer's order the price list in effect as of Customer's requested shipping date).

INSTALLATION PRICING

Customer shall pay SEDIA SYSTEMS for the Services, including without limitation, SEDIA SYSTEMS Certified/Approved Installer or the supervision of such installation at the prices set forth in the Contract.

FREIGHT TERMS

SEDIA SYSTEMS reserves the right to select the "best way" shipment methods and means (including, but not limited to, determination of the carrier, method of shipment, and routing). All shipments of Products are F.O.B. Origin. Freight charges are estimated at the time of Order, and are based on shipments to the 48 U.S. contiguous states. Customer shall pay all freight charges, and shall pay any increases in freight charges by the carrier at the time of shipment and Delivery (as defined below), extra expenses resulting from any request by Customer for after-hours, holiday, weekend, or specific time Delivery, or special carrier, shipping method, (e.g. air freight, exclusive use vehicle) packaging, and/or routing. At Customer's option, Customer may request quotes for freight charges or it may pick up the Products itself.

DELIVERY

1. Delivery of the Products is completed on the loading of the Products onto the carrier at origin. ("Delivery" or "Deliver").
2. SEDIA SYSTEMS will consider requests for Delivery times and for drop shipments to job sites, and will undertake reasonable efforts to indicate any such request(s) to product carriers; however, any dates quoted for Delivery are approximate only, and the time of Delivery is not of the essence. SEDIA SYSTEMS may, in its sole discretion, extend to Customer the option of a carrier-guaranteed set Delivery time at an additional cost to Customer. SEDIA SYSTEMS shall not be liable for any delay in Delivery of the Products that is caused by a Force Majeure Event (as defined below) or the Customer's failure to provide SEDIA SYSTEMS with adequate Delivery instructions or any other instructions that are relevant to the shipment and Delivery of the Products. Under all other circumstances, SEDIA SYSTEMS' liability for any and all damages incurred for any late Delivery when Customer has paid for a carrier-guaranteed set Delivery time, including all labor and other expenses resulting from any such delays, shall be limited to a refund to Customer of the charge for the aforementioned carrier-guaranteed Delivery time.
3. In the event SEDIA SYSTEMS fails to Deliver the Products, its total liability shall be limited to any amounts actually paid by the Customer to SEDIA SYSTEMS for the Products. INSTALLATION

1. SEDIA SYSTEMS will use reasonable efforts to meet any performance dates for the Services specified in the Contract, but any such dates shall be estimates only and time shall not be of the essence for performance of the Services.
2. As part of the Services, Customer shall pay for SEDIA SYSTEMS to install all fixed seating product by a certified/approved installer provided by SEDIA SYSTEMS ("SEDIA SYSTEMS Certified/Approved Installer") unless agreed to in writing by SEDIA SYSTEMS and Customer that Customer may retain an installer who is not a SEDIA SYSTEMS' Certified/Approved Installer; provided, however, in such an event and at the determination of SEDIA SYSTEMS, Customer shall retain and pay SEDIA SYSTEMS to supervise such installation. 3. 4. In the event Customer does not retain and pay SEDIA SYSTEMS for a SEDIA SYSTEMS Certified/Approved Installer, and instead Customer hires Customer's own installer to install the fixed seating products, Customer hereby releases and discharges SEDIA SYSTEMS from any and all liability and damages to Customer, Customer's end user, Customer's installer and any third party arising out of and/or related to the installation of the fixed seating products, including without limitation, all personal injuries, death or damage to property. Customer shall be solely liable for any damages arising out of and/or related to the installation of the fixed seating products.
5. Customer shall indemnify, defend and hold harmless SEDIA SYSTEMS, its owners, officers, directors, employees and agents from and against any and all liabilities, claims, judgments and damages of every kind and nature, including without limitation, costs and attorney's fees, arising out of and/or related to all third party claims against SEDIA SYSTEMS arising from and/or related to (a) the Customer and/or Customer's agent's acts or omissions in connection with the installation of the fixed seating products and/or (b) the use of the fixed seating products after any improper installation of the fixed seating products by Customer and/or Customer's agents.
6. Installation of the fixed seating products by Customer and its agents and not by SEDIA SYSTEMS' Certified/Approved Installer may, in SEDIA SYSTEMS' sole discretion, void the Products Warranty and will void the Services Warranty.

PAYMENT TERMS

Unless otherwise agreed in a writing signed by both parties, payment on all SEDIA SYSTEMS invoices shall be made in U.S. dollars as follows: fifty percent (50%) of the amount of the invoice accompanying SEDIA SYSTEMS' acknowledgment of the Order, due upon Customer's receipt of the invoice, and the balance of the invoiced amount within thirty (30) days after the date of such invoice. All payments shall be without offset, back charges, retention, or withholding of any kind. Unpaid deposits and delinquent invoices which remain unpaid or delinquent for more than 10 days after their due date shall accrue interest from the due date at the rate of one and one-half percent (1.5%) per month, or the highest rate permitted by law.

DEFAULT

1. ("Default")
2. Upon a Default, without waiver of SEDIA SYSTEMS' right to exercise any other remedy provided herein or otherwise by law or in equity, SEDIA SYSTEMS' remedies include but are not limited to any or all of the following: (a) termination of any Order and Contract; (b) suspending production, shipment, Delivery and/or installation of Products and/or Services; (c) termination of all pending Orders and Contracts and recover any cancellation charges from Customer; (d) repossessing any Products pursuant to its security interest and selling any such Products; (e) initiate legal process to recover all monies owed, and (f) reimbursement by Customer to SEDIA SYSTEMS for all reasonable expenses of enforcement of any Order, Contract and these Terms & Conditions including, without limitation, reasonable attorneys' fees and other legal costs and including all such costs (including reasonable attorney fees) associated with collecting delinquent or dishonored payments or with collecting or enforcing any Order, Contract and these Terms & Conditions including in any Customer bankruptcy proceeding.

SEDIA SYSTEMS shall not be in breach of the Order or Contract nor liable in delay in performing or failure to perform any of its obligations under the Order and/or Contract and/or SEDIA SYSTEMS may terminate any Order and Contract or the Delivery and/or installation of any Products and/or Services upon written notice to Customer without liability if, in SEDIA SYSTEMS' sole reasonable discretion, providing the Products, or any Product, and/or installation of any Product or the provision of any other Services may be prohibited by law, statute, legislation, order, regulation or guidance issued by a court of law, governmental body or regulatory body, or by any contract to which SEDIA SYSTEMS is a party, or the occurrence of one or more of the following impediments, beyond SEDIA SYSTEMS' reasonable control where the Products, or any of them, cannot be Delivered and/or installed or the Services cannot be performed for reasons including, without limitation, Acts of God, fire, lightning, explosion, war (whether declared or not), armed conflict or the serious threat of the same (including but not limited to hostile attack, blockade, military embargo), hostilities, invasion, act of a foreign enemy, extensive military mobilization; civil war, rebellion, revolution, military or usurped power, insurrection, embargo, civil commotion or disorder, mob violence, act of civil disobedience; terrorism, riot, sabotage, or piracy; plague, epidemic, pandemic, outbreaks of infectious disease or any other public health crisis, including quarantine or other employee restrictions; disorder, flood, draught; weather of exceptional severity, natural disaster; acts of local or central government or other authorities or regulatory bodies, act of authority whether lawful or unlawful, compliance with any law or governmental order, rule, regulation or direction, curfew restriction, expropriation, compulsory acquisition, seizure of works, requisition, nationalization; industrial disputes (whether or not involving SEDIA SYSTEMS' employees), transportation delays, destruction of machines, equipment, factories and of any kind of installation, prolonged break-down of transport, telecommunication or electric current; general labor disturbance or disputes such as but not limited to boycott, strike and lock-out, go-slow, occupation of factories and premises; shortage or inability to obtain critical material or supplies to the extent not subject to the reasonable control of SEDIA SYSTEMS, computer failure, hardware failure, telecommunications failure, electronic mail failure, power failure, or failure of Customer to cooperate with the reasonable requests of SEDIA SYSTEMS. ACKNOWLEDGMENTS

No order is deemed accepted by SEDIA SYSTEMS until: (i) an acknowledgment is made by SEDIA SYSTEMS at its headquarters in Chicago and (ii) SEDIA SYSTEMS sends the written acknowledgment to Customer ("Order"). SEDIA SYSTEMS sends acknowledgments on all accepted orders. Please read these acknowledgments and contact SEDIA SYSTEMS immediately if there is any discrepancy. In the event of any difference or inconsistency between SEDIA SYSTEMS' acknowledgment and Customer's purchase order, SEDIA SYSTEMS' acknowledgment will control. In the event the model number and description differ on the purchase order, the model number will be the determining factor. Any error or discrepancy on acknowledgment must be reported to SEDIA SYSTEMS in writing within three (3) working days of acknowledgment date. All acknowledgments contain an estimated shipping and Delivery date, but an Order may Deliver earlier than the estimated Delivery date. If Customer desires Delivery on or after a specified date, Customer must write "Do not ship for arrival before [date]" on Customer's purchase order. Lead time for fixed seating projects begins from the date of signed shop drawings from the Customer. Initial Delivery date acknowledgement for fixed seating will be an estimate based on information provided at the time of Order.

FAX ORDERS

Orders may be sent to SEDIA SYSTEMS via facsimile (312-277-7160). If, following submission of a facsimile order to SEDIA SYSTEMS, Customer sends a confirming order, such confirming order must be marked "Confirming Order. Original order sent via fax." SEDIA SYSTEMS will not be responsible for any duplication orders caused by unmarked hard copy, duplicative confirming orders, or orders sent via facsimile more than once.

CHANGES OR CANCELLATIONS OF ORDERS / CONTRACTS

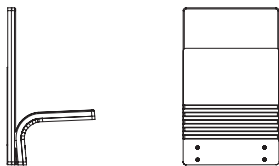
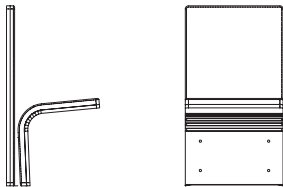
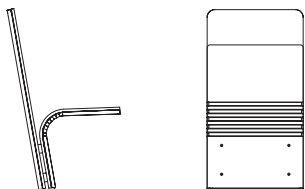

TERMS & CONDITIONS GOVERN

The SEDIA SYSTEMS Terms & Conditions ("Terms & Conditions") shall apply to and govern all transactions, sales and purchases of seating and/or other products ("Products") and any related installation and/or other services ("Services") between SEDIA SYSTEMS and SEDIA SYSTEMS' end user, dealer, contractor or other customer ("Customer"). SEDIA SYSTEMS shall not be bound and no writing will constitute an "Order" unless and until such writing is acknowledged by SEDIA SYSTEMS as provided below. Customer shall be responsible for ensuring that the terms of the Order and any specification for the Services that are agreed in writing by SEDIA SYSTEMS and Customer, including any Customer approved drawings of the installation of the Products, are complete and accurate ("Specification"). PRODUCT PRICING

ALL FIXED SEATING PRODUCT PRICE LISTS ARE PRICED WITHOUT FREIGHT, SHIPPING AND INSTALLATION CHARGES. JUMPSEAT AND COMPLEMENTARY PRODUCT PRICE LISTS ARE PRICED WITH FREIGHT (ASSUMING SHIPMENT TO THE 48 U.S. CONTIGUOUS STATES) BUT WITHOUT INSTALLATION CHARGES. All shipments of Products are F.O.B. Origin. Freight charges are estimated at the time of Order, and are based on shipments to the 48 U.S. contiguous states. Customer shall pay all freight charges, and shall pay any increases in freight charges by the carrier at the time of shipment and Delivery (as defined below), extra expenses resulting from any request by Customer for after-hours, holiday, weekend, or specific time Delivery, or special carrier, shipping method, (e.g. air freight, exclusive use vehicle) packaging, and/or routing. At Customer's option, Customer may request quotes for freight charges or it may pick up the Products itself.

DELIVERY

1. Delivery of the Products is completed on the loading of the Products onto the carrier at origin. ("Delivery" or "Deliver").
2. SEDIA SYSTEMS will consider requests for Delivery times and for drop shipments to job sites, and will undertake reasonable efforts to indicate any such request(s) to product carriers; however, any dates quoted for Delivery are approximate only, and the time of Delivery is not of the essence. SEDIA SYSTEMS may, in its sole discretion, extend to Customer the option of a carrier-guaranteed set Delivery time at an additional cost to Customer. SEDIA SYSTEMS shall not be liable for any delay in Delivery of the Products that is caused by a Force Majeure Event (as defined below) or the Customer's failure to provide SEDIA SYSTEMS with adequate Delivery instructions or any other instructions that are relevant to the shipment and Delivery of the Products. Under all other circumstances, SEDIA SYSTEMS' liability for any and all damages incurred for any late Delivery when Customer has paid for a carrier-guaranteed set Delivery time, including all labor and other expenses resulting from any such delays, shall be limited to a refund to Customer of the charge for the aforementioned carrier-guaranteed Delivery time.
3. In the event SEDIA SYSTEMS fails to Deliver the Products, its total liability shall be limited to any amounts actually paid by the Customer to SEDIA SYSTEMS for the Products. However, SEDIA SYSTEMS shall have no liability for any failure to Deliver the Products to the extent that such failure is caused by a Force Majeure Event or the Customer's failure to provide SEDIA SYSTEMS with adequate Delivery instructions or any other instructions that are relevant to the shipment and Delivery of the Products.

Terms & Conditions

INSTALLATION

1. SEDIA SYSTEMS will use reasonable efforts to meet any performance dates for the Services specified in the Contract, but any such dates shall be estimates only and time shall not be of the essence for performance of the Services.
2. As part of the Services, Customer shall pay for SEDIA SYSTEMS to install all fixed seating product by a certified/approved installer provided by SEDIA SYSTEMS ("SEDIA SYSTEMS Certified/Approved Installer") unless agreed to in writing by SEDIA SYSTEMS and Customer that Customer may retain an installer who is not a SEDIA SYSTEMS' Certified/Approved Installer; provided, however, in such an event and at the determination of SEDIA SYSTEMS, Customer shall retain and pay SEDIA SYSTEMS to supervise such installation. Customer shall pay for the SEDIA SYSTEMS Certified/Approved Installer or the supervision of such installation at the prices set forth in the Contract.
3. In the event Customer does not retain and pay SEDIA SYSTEMS for a SEDIA SYSTEMS Certified/Approved Installer, and instead Customer hires Customer's own installer to install the fixed seating products, Customer shall obtain and maintain liability insurance in amounts acceptable to SEDIA SYSTEMS to cover death, personal injury, property damage and similar damages relating to the installation of all fixed seating products by Customer and Customer's agents. Customer shall cause SEDIA SYSTEMS to be named as an additional insured on all such policies. Customer shall provide SEDIA SYSTEMS with certificates and/or endorsements reflecting such coverage upon SEDIA SYSTEMS' request.
4. In the event Customer does not retain and pay SEDIA SYSTEMS for a SEDIA SYSTEMS Certified/Approved Installer, and instead Customer hires Customer's own installer to install the fixed seating products, Customer hereby releases and discharges SEDIA SYSTEMS from any and all liability and damages to Customer, Customer's end user, Customer's installer and any third party arising out of and/or related to the installation of the fixed seating products, including without limitation, all personal injuries, death or damage to property. Customer shall be solely liable for any damages arising out of and/or related to the installation of the fixed seating products.
5. Customer shall indemnify, defend and hold harmless SEDIA SYSTEMS, its owners, officers, directors, employees and agents from and against any and all liabilities, claims, judgments and damages of every kind and nature, including without limitation, costs and attorney's fees, arising out of and/or related to all third party claims against SEDIA SYSTEMS arising from and/or related to (a) the Customer and/or Customer's agent's acts or omissions in connection with the installation of the fixed seating products and/or (b) the use of the fixed seating products after any improper installation of the fixed seating products by Customer and/or Customer's agents.
6. Installation of the fixed seating products by Customer and its agents and not by SEDIA SYSTEMS' Certified/Approved Installer may, in SEDIA SYSTEMS' sole discretion, void the Products Warranty and will void the Services Warranty.

PAYMENT TERMS

Unless otherwise agreed in a writing signed by both parties, payment on all SEDIA SYSTEMS invoices shall be made in U.S. dollars as follows: fifty percent (50%) of the amount of the invoice accompanying SEDIA SYSTEMS' acknowledgment of the Order, due upon Customer's receipt of the invoice, and the balance of the invoiced amount within thirty (30) days after the date of such invoice. All payments shall be without offset, back charges, retention, or withholding of any kind. Unpaid deposits and delinquent invoices which remain unpaid or delinquent for more than 10 days after their due date shall accrue interest from the due date at the rate of one and one-half percent (1.5%) per month, or the highest rate permitted by law.

DEFAULT

1. Customer shall be in default of any Order and/or Contract in the event of any of the following events: (a) Customer fails to make any payment due under any Order, Contract or invoice from SEDIA SYSTEMS within ten (10) days after the due date, (b) Customer breaches any other material terms of the Order, Contract and/or these Terms & Conditions which is not cured by Customer within ten (10) days of written notice by SEDIA SYSTEMS, (c) Customer terminates or suspends its business operations, or (d) Customer makes an assignment for the benefit of creditors, files for protection under the U.S. Bankruptcy Court or similar law or has a bankruptcy petition filed against Customer which is not discharged within thirty (30) days of filing, or Customer takes any other step or action to liquidate or have a receiver appointed to any of its assets. ("Default")
2. Upon a Default, without waiver of SEDIA SYSTEMS' right to exercise any other remedy provided herein or otherwise by law or in equity, SEDIA SYSTEMS' remedies include but are not limited to any or all of the following: (a) termination of any Order and Contract; (b) suspending production, shipment, Delivery and/or installation of Products and/or Services; (c) termination of all pending Orders and Contracts and recover any cancellation charges from Customer; (d) repossessing any Products pursuant to its security interest and selling any such Products; (e) initiate legal process to recover all monies owed, and (f) reimbursement by Customer to SEDIA SYSTEMS for all reasonable expenses of enforcement of any Order, Contract and these Terms & Conditions including, without limitation, reasonable attorneys' fees and other legal costs and including all such costs (including reasonable attorney fees) associated with collecting delinquent or dishonored payments or with collecting or enforcing any Order, Contract and these Terms & Conditions including in any Customer bankruptcy proceeding.
3. On termination of the Order and/or Contract for any reason, the Customer shall immediately pay to SEDIA SYSTEMS all amounts due under the Order, Contract and these Terms & Conditions including all outstanding unpaid invoices and interest.

FORCE MAJEURE

SEDIA SYSTEMS sends acknowledgments on all accepted orders. Please read these acknowledgments and contact SEDIA SYSTEMS immediately if there is any discrepancy. In the event of any difference or inconsistency between SEDIA SYSTEMS' acknowledgment and Customer's purchase order, SEDIA SYSTEMS' acknowledgment will control. In the event the model number and description differ on the purchase order, the model number will be the determining factor. Any error or discrepancy on acknowledgment must be reported to SEDIA SYSTEMS in writing within three (3) working days of acknowledgment date. All acknowledgments contain an estimated shipping and Delivery date, but an Order may Deliver earlier than the estimated Delivery date. Terms & Conditions

TERMS & CONDITIONS GOVERN

The SEDIA SYSTEMS Terms & Conditions ("Terms & Conditions") shall apply to and govern all transactions, sales and purchases of seating and/or other products ("Products") and any related installation and/or other services ("Services") between SEDIA SYSTEMS and SEDIA SYSTEMS' end user, dealer, contractor or other customer ("Customer"). Except as otherwise expressly excluded by agreement, in writing, signed by SEDIA SYSTEMS and Customer, (i) these Terms & Conditions shall apply to and are incorporated into all agreements, whether written, oral or implied, with respect to the purchase of any Products and/or Services from SEDIA SYSTEMS by Customer pursuant to any quote, proposal, purchase order, invoice, contract, subcontract, or any other document related to the Products and/or Services provided by SEDIA SYSTEMS to Customer and into all orders, (ii) in the event Customer submitted an order, contract, subcontract or other Customer document reflecting terms and conditions applicable to Products and/or Services that conflict with these Terms & Conditions, these Terms & Conditions shall control, and (iii) Customer's acceptance of the Products and/or Services is conditioned upon acceptance by Customer of these Terms & Conditions and no others, and reflects Customer's assent to SEDIA SYSTEMS' Terms & Conditions as set forth herein. SEDIA SYSTEMS shall not be bound and no writing will constitute an "Order" unless and until such writing is acknowledged by SEDIA SYSTEMS as provided below. Customer shall be responsible for ensuring that the terms of the Order and any specification for the Services that are agreed in writing by SEDIA SYSTEMS and Customer, including any Customer approved drawings of the installation of the Products, are complete and accurate ("Specification"). Acceptance and acknowledgment of an Order by SEDIA SYSTEMS or if no written acceptance is issued, then the execution of an agreement between SEDIA SYSTEMS and its Customer or performance by SEDIA SYSTEMS of shipment of the Products or commencement of the Services constitutes a contract between SEDIA SYSTEMS and Customer ("Contract"), and the Contract is pursuant to these Terms & Conditions only, and constitutes a rejection of any additional or conflicting terms and conditions of Customer. To the extent drawings of the installation of the Products are approved by Customer after the Contract, Customer and SEDIA SYSTEMS agree that such approved drawings after the Contract shall be deemed part of the Specification and incorporated into the Contract. SEDIA SYSTEMS may modify these Terms & Conditions with notice. Changes shall be effective for all quotes issued by SEDIA SYSTEMS after the date of the modification.

PRODUCT PRICING

ALL FIXED SEATING PRODUCT PRICE LISTS ARE PRICED WITHOUT FREIGHT, SHIPPING AND INSTALLATION CHARGES. JUMPSEAT AND COMPLEMENTARY PRODUCT PRICE LISTS ARE PRICED WITH FREIGHT (ASSUMING SHIPMENT TO THE 48 U.S. CONTIGUOUS STATES) BUT WITHOUT INSTALLATION CHARGES. SEDIA SYSTEMS' prices applicable to all Customer orders shall be those in effect at the time SEDIA SYSTEMS receives a complete order from Customer unless: Customer and SEDIA SYSTEMS have in place a written special pricing or master supply agreement, which agreement specifies the prices to be paid by Customer; or Customer requests a Product shipping date to occur more than one hundred twenty (120) days after SEDIA SYSTEMS' receipt of Customer's order (in which case SEDIA SYSTEMS shall have the option to apply to Customer's order the price list in effect as of Customer's requested shipping date).

INSTALLATION PRICING

Customer shall pay SEDIA SYSTEMS for the Services, including without limitation, SEDIA SYSTEMS Certified/Approved Installer or the supervision of such installation at the prices set forth in the Contract.

FREIGHT TERMS

SEDIA SYSTEMS reserves the right to select the "best way" shipment methods and means (including, but not limited to, determination of the carrier, method of shipment, and routing). All shipments of Products are F.O.B. Origin. Freight charges are estimated at the time of Order, and are based on shipments to the 48 U.S. contiguous states. Customer shall pay all freight charges, and shall pay any increases in freight charges by the carrier at the time of shipment and Delivery (as defined below), extra expenses resulting from any request by Customer for after-hours, holiday, weekend, or specific time Delivery, or special carrier, shipping method, (e.g. air freight, exclusive use vehicle) packaging, and/or routing. At Customer's option, Customer may request quotes for freight charges or it may pick up the Products itself.

DELIVERY

1. Delivery of the Products is completed on the loading of the Products onto the carrier at origin. ("Delivery" or "Deliver").
2. SEDIA SYSTEMS will consider requests for Delivery times and for drop shipments to job sites, and will undertake reasonable efforts to indicate any such request(s) to product carriers; however, any dates quoted for Delivery are approximate only, and the time of Delivery is not of the essence. SEDIA SYSTEMS may, in its sole discretion, extend to Customer the option of a carrier-guaranteed set Delivery time at an additional cost to Customer. SEDIA SYSTEMS shall not be liable for any delay in Delivery of the Products that is caused by a Force Majeure Event (as defined below) or the Customer's failure to provide SEDIA SYSTEMS with adequate Delivery instructions or any other instructions that are relevant to the shipment and Delivery of the Products. Under all other circumstances, SEDIA SYSTEMS' liability for any and all damages incurred for any late Delivery when Customer has paid for a carrier-guaranteed set Delivery time, including all labor and other expenses resulting from any such delays, shall be limited to a refund to Customer of the charge for the aforementioned carrier-guaranteed Delivery time.
3. In the event SEDIA SYSTEMS fails to Deliver the Products, its total liability shall be limited to any amounts actually paid by the Customer to SEDIA SYSTEMS for the Products. However, SEDIA SYSTEMS shall have no liability for any failure to Deliver the Products to the extent that such failure is caused by a Force Majeure Event or the Customer's failure to provide SEDIA SYSTEMS with adequate Delivery instructions or any other instructions that are relevant to the shipment and Delivery of the Products.

Terms & Conditions

INSTALLATION

1. SEDIA SYSTEMS will use reasonable efforts to meet any performance dates for the Services specified in the Contract, but any such dates shall be estimates only and time shall not be of the essence for performance of the Services.
2. As part of the Services, Customer shall pay for SEDIA SYSTEMS to install all fixed seating product by a certified/approved installer provided by SEDIA SYSTEMS ("SEDIA SYSTEMS Certified/Approved Installer") unless agreed to in writing by SEDIA SYSTEMS and Customer that Customer may retain an installer who is not a SEDIA SYSTEMS' Certified/Approved Installer; provided, however, in such an event and at the determination of SEDIA SYSTEMS, Customer shall retain and pay SEDIA SYSTEMS to supervise such installation. Customer shall pay for the SEDIA SYSTEMS Certified/Approved Installer or the supervision of such installation at the prices set forth in the Contract.
3. In the event Customer does not retain and pay SEDIA SYSTEMS for a SEDIA SYSTEMS Certified/Approved Installer, and instead Customer hires Customer's own installer to install the fixed seating products, Customer shall obtain and maintain liability insurance in amounts acceptable to SEDIA SYSTEMS to cover death, personal injury, property damage and similar damages relating to the installation of all fixed seating products by Customer and Customer's agents. Customer shall cause SEDIA SYSTEMS to be named as an additional insured on all such policies. Customer shall provide SEDIA SYSTEMS with certificates and/or endorsements reflecting such coverage upon SEDIA SYSTEMS' request.
4. In the event Customer does not retain and pay SEDIA SYSTEMS for a SEDIA SYSTEMS Certified/Approved Installer, and instead Customer hires Customer's own installer to install the fixed seating products, Customer hereby releases and discharges SEDIA SYSTEMS from any and all liability and damages to Customer, Customer's end user, Customer's installer and any third party arising out of and/or related to the installation of the fixed seating products, including without limitation, all personal injuries, death or damage to property. Customer shall be solely liable for any damages arising out of and/or related to the installation of the fixed seating products.
5. Customer shall indemnify, defend and hold harmless SEDIA SYSTEMS, its owners, officers, directors, employees and agents from and against any and all liabilities, claims, judgments and damages of every kind and nature, including without limitation, costs and attorney's fees, arising out of and/or related to all third party claims against SEDIA SYSTEMS arising from and/or related to (a) the Customer and/or Customer's agent's acts or omissions in connection with the installation of the fixed seating products and/or (b) the use of the fixed seating products after any improper installation of the fixed seating products by Customer and/or Customer's agents.
6. Installation of the fixed seating products by Customer and its agents and not by SEDIA SYSTEMS' Certified/Approved Installer may, in SEDIA SYSTEMS' sole discretion, void the Products Warranty and will void the Services Warranty.

PAYMENT TERMS

Unless otherwise agreed in a writing signed by both parties, payment on all SEDIA SYSTEMS invoices shall be made in U.S. dollars as follows: fifty percent (50%) of the amount of the invoice accompanying SEDIA SYSTEMS' acknowledgment of the Order, due upon Customer's receipt of the invoice, and the balance of the invoiced amount within thirty (30) days after the date of such invoice. All payments shall be without offset, back charges, retention, or withholding of any kind. Unpaid deposits and delinquent invoices which remain unpaid or delinquent for more than 10 days after their due date shall accrue interest from the due date at the rate of one and one-half percent (1.5%) per month, or the highest rate permitted by law.

DEFAULT

1. Customer shall be in default of any Order and/or Contract in the event of any of the following events: (a) Customer fails to make any payment due under any Order, Contract or invoice from SEDIA SYSTEMS within ten (10) days after the due date, (b) Customer breaches any other material terms of the Order, Contract and/or these Terms & Conditions which is not cured by Customer within ten (10) days of written notice by SEDIA SYSTEMS, (c) Customer terminates or suspends its business operations, or (d) Customer makes an assignment for the benefit of creditors, files for protection under the U.S. Bankruptcy Court or similar law or has a bankruptcy petition filed against Customer which is not discharged within thirty (30) days of filing, or Customer takes any other step or action to liquidate or have a receiver appointed to any of its assets. ("Default")
2. Upon a Default, without waiver of SEDIA SYSTEMS' right to exercise any other remedy provided herein or otherwise by law or in equity, SEDIA SYSTEMS' remedies include but are not limited to any or all of the following: (a) termination of any Order and Contract; (b) suspending production, shipment, Delivery and/or installation of Products and/or Services; (c) termination of all pending Orders and Contracts and recover any cancellation charges from Customer; (d) repossessing any Products pursuant to its security interest and selling any such Products; (e) initiate legal process to recover all monies owed, and (f) reimbursement by Customer to SEDIA SYSTEMS for all reasonable expenses of enforcement of any Order, Contract and these Terms & Conditions including, without limitation, reasonable attorneys' fees and other legal costs and including all such costs (including reasonable attorney fees) associated with collecting delinquent or dishonored payments or with collecting or enforcing any Order, Contract and these Terms & Conditions including in any Customer bankruptcy proceeding.
3. On termination of the Order and/or Contract for any reason, the Customer shall immediately pay to SEDIA SYSTEMS all amounts due under the Order, Contract and these Terms & Conditions including all outstanding unpaid invoices and interest.

Terms & Conditions

FORCE MAJEURE

SEDIA SYSTEMS shall not be in breach of the Order or Contract nor liable in delay in performing or failure to perform any of its obligations under the Order and/or Contract and/or SEDIA SYSTEMS may terminate any Order and Contract or the Delivery and/or installation of any Products and/or Services upon written notice to Customer without liability if, in SEDIA SYSTEMS' sole reasonable discretion, providing the Products, or any Product, and/or installation of any Product or the provision of any other Services may be prohibited by law, statute, legislation, order, regulation or guidance issued by a court of law, governmental body or regulatory body, or by any contract to which SEDIA SYSTEMS is a party, or the occurrence of one or more of the following impediments, beyond SEDIA SYSTEMS' reasonable control where the Products, or any of them, cannot be Delivered and/or installed or the Services cannot be performed for reasons including, without limitation, Acts of God, fire, lightning, explosion, war (whether declared or not), armed conflict or the serious threat of the same (including but not limited to hostile attack, blockade, military embargo), hostilities, invasion, act of a foreign enemy, extensive military mobilization; civil war, rebellion, revolution, military or usurped power, insurrection, embargo, civil commotion or disorder, mob violence, act of civil disobedience; terrorism, riot, sabotage, or piracy; plague, epidemic, pandemic, outbreaks of infectious disease or any other public health crisis, including quarantine or other employee restrictions; disorder, flood, draught; weather of exceptional severity, natural disaster; acts of local or central government or other authorities or regulatory bodies, act of authority whether lawful or unlawful, compliance with any law or governmental order, rule, regulation or direction, curfew restriction, expropriation, compulsory acquisition, seizure of works, requisition, nationalization; industrial disputes (whether or not involving SEDIA SYSTEMS' employees), transportation delays, destruction of machines, equipment, factories and of any kind of installation, prolonged break-down of transport, telecommunication or electric current; general labor disturbance or disputes such as but not limited to boycott, strike and lock-out, go-slow, occupation of factories and premises; shortage or inability to obtain critical material or supplies to the extent not subject to the reasonable control of SEDIA SYSTEMS, computer failure, hardware failure, telecommunications failure, electronic mail failure, power failure, or failure of Customer to cooperate with the reasonable requests of SEDIA SYSTEMS. ("Force Majeure Event")

SECURITY INTEREST IN PRODUCTS

SEDIA SYSTEMS shall retain a purchase money security interest in all Products sold to Customer and for which Customer has not made full payment. Customer agrees to execute any and all instruments necessary to document the creation of this security interest and/or to perfect the same. Customer further agrees to assemble and deliver to SEDIA SYSTEMS all Products subject to this security interest in the event of a Default.

ACKNOWLEDGMENTS

No order is deemed accepted by SEDIA SYSTEMS until: (i) an acknowledgment is made by SEDIA SYSTEMS at its headquarters in Chicago and (ii) SEDIA SYSTEMS sends the written acknowledgment to Customer ("Order"). SEDIA SYSTEMS sends acknowledgments on all accepted orders. Please read these acknowledgments and contact SEDIA SYSTEMS immediately if there is any discrepancy. In the event of any difference or inconsistency between SEDIA SYSTEMS' acknowledgment and Customer's purchase order, SEDIA SYSTEMS' acknowledgment will control. In the event the model number and description differ on the purchase order, the model number will be the determining factor. Any error or discrepancy on acknowledgment must be reported to SEDIA SYSTEMS in writing within three (3) working days of acknowledgment date. All acknowledgments contain an estimated shipping and Delivery date, but an Order may Deliver earlier than the estimated Delivery date. If Customer desires Delivery on or after a specified date, Customer must write "Do not ship for arrival before [date]" on Customer's purchase order. Lead time for fixed seating projects begins from the date of signed shop drawings from the Customer. Initial Delivery date acknowledgement for fixed seating will be an estimate based on information provided at the time of Order.

FAX ORDERS

Orders may be sent to SEDIA SYSTEMS via facsimile (312-277-7160). If, following submission of a facsimile order to SEDIA SYSTEMS, Customer sends a confirming order, such confirming order must be marked "Confirming Order. Original order sent via fax." SEDIA SYSTEMS will not be responsible for any duplication orders caused by unmarked hard copy, duplicative confirming orders, or orders sent via facsimile more than once.

CHANGES OR CANCELLATIONS OF ORDERS / CONTRACTS

Orders acknowledged by SEDIA SYSTEMS and/or Contracts cannot be changed or cancelled without SEDIA SYSTEMS' written consent, which consent may be conditioned upon Customer's agreement to pay increased or additional expenses resulting from the requested change or cancellation including but not limited to a twenty-five percent (25%) cancellation charge if the Order and/or Contract is cancelled or changed at least thirty (30) days before Delivery. No refund or credit will be given for Orders and/or Contracts cancelled within thirty (30) days of Delivery or Orders and/or Contracts involving custom product.

TITLE AND RISK OF LOSS

Title to Product shall pass to Customer upon Delivery by SEDIA SYSTEMS. Customer agrees and acknowledges that upon Delivery by SEDIA SYSTEMS of the Product to the carrier at origin, risk of loss passes to Customer. If Customer receives Product that is freight damaged, Customer must take the following steps: (1) Before signing for the merchandise, make careful notation of all damages on the bill of lading or delivery receipt; (2) Immediately file a claim with the delivery carrier. Request an inspection by the carrier agent; (3) The claim must be filed within fifteen (15) days of receipt of Products; and (4) Retain all shipping cartons for inspection by the carrier agent. For concealed damages follow steps (2) through (4). SEDIA SYSTEMS DOES NOT CARRY INSURANCE ON THE PRODUCTS AND CUSTOMER SHALL BEAR THE RISK OF LOSS AFTER THE PRODUCTS ARE DELIVERED TO THE CARRIER. SEDIA SYSTEMS is not responsible for Products damaged, stolen or lost in transportation.

Terms & Conditions

SHIPMENT DAMAGE CLAIMS

All Products are packaged to comply with carrier requirements and leave SEDIA SYSTEMS' manufacturing facilities in good condition. Customer shall be responsible for careful inspection of all Product upon Delivery and before acceptance. Any damage discovered upon Delivery must be noted on the bill of lading. Notification of damage discovered after Delivery must be given to the carrier within fifteen (15) days immediately following Delivery, and all damaged Product must be kept at the point of Delivery in its original packaging. WARRANTY

A. Products Warranty:

SEDIA SYSTEMS warrants Products purchased hereunder to be substantially free from defects in materials and workmanship provided SEDIA SYSTEMS receives written notice of an alleged defect within the time periods set forth below ("Products Warranty"). SEDIA SYSTEMS will, at its sole option, repair or replace Product that it determines to be defective as a result of faulty material or workmanship:

Repair or Replacement is Sole Remedy

Such repair or replacement shall be the sole and exclusive remedy for any breach of the Products Warranty. Customer agrees and acknowledges that such repair or replacement is an adequate remedy. In the event SEDIA SYSTEMS fails to repair or replace a Product it has determined is defective as provided herein, the Customer's sole remedy shall be the return of the purchase price actually paid by Customer for the defective Product on a prorated basis based upon a useful life of ten (10) years.

B. Services Warranty:
