The University of California, Office of the President (UC) issued RFP # 002197-SEP2020 on October 2, 2020 to establish a national cooperative contract to assist UC and national participating agencies, in obtaining the best, most cost-effective and efficient procurement program for IT Security Tools

The purpose of this Request for Proposal (the "RFP") is to invite qualified IT security tools suppliers ("Supplier(s)") to prepare and submit proposals to the University of California ("UC") to provide IT security tools and associated products and services ("IT Security Tools") in the six categories described below that will provide maximum value to the UC through enhanced technology, superior customer service, streamlined processes, and lower total cost of ownership ("Goods and Services") all in accordance with Federal and State of California laws and the requirements of the UC as further detailed in this RFP. The UC has partnered with OMNIA Partners to make the resultant agreement a national cooperative agreement which public agencies, across the country will be able to utilize.

The overall objective of this RFP is to select a Supplier, or multiple Suppliers, to assist UC, and national participating agencies, in obtaining the best, most cost-effective and efficient procurement program for Security Tools. In addition, qualified Suppliers are invited to submit proposals, based on the information provided in this RFP with the intent to establish a business alliance with UC and OMNIA Partners, that will maximize the resources of both organizations to most effectively meet national participating agencies' and the UC's, needs.
